

Remembering Julie Mader Hostetter

The Brethren Academy for Ministerial Leadership remembers our former executive director, Julie Mader Hostetter, who passed away November 12, 2017, in Bridgewater, Virginia.



Julie served as director, and then executive director, beginning in 2008. Under her leadership, Academy programs expanded and flourished. To Training in Ministry (TRIM) and Education for a Shared Ministry (EFSM), Julie added Seminario Biblico Anabautista Hispano (SeBAH-COB) and an EFSM Spanish-language track to better serve Spanish-speaking Brethren. To administrate these programs, Julie oversaw the creation of a new staff position, the coordinator for Spanish-language ministry training programs.

Through the work of the Academy, Julie also provided leadership for continuing education for clergy. She administered the programs Sustaining Pastoral Excellence, Sustaining Ministerial Excellence, and Supervision in Ministry. She taught many of the sessions for these programs as well as other courses, including Administration as Pastoral Care. In 2015, at the request of the Office of Ministry, Julie assumed responsibility for ministerial ethics training in the denomination, for all ordained ministers just prior to ordination review.

Julie Hostetter retired from the Academy in January 2017. She left a legacy of successful programs with a bright future. Julie's spirit, professionalism, discipline, dedication, keen sense of observation, wry wit, and deep kindness will long be remembered and celebrated by all of us at the Brethren Academy.

A worship service celebrating Julie's faith and life was held on December 2 at the Bridgewater Church of the Brethren. To honor her dedication to ministry education, the Hostetter family has established the Julie Mader Hostetter Brethren Academy for Ministerial Leadership Scholarship Fund. UPCOMING COURSE HIGHLIGHTS

Did you know Brethren Academy courses are for everyone? TRIM and EFSM students receive 1 unit per course, credentialed clergy earn 2.0 continuing education units (CEUs), and *anyone* can enroll for their own personal and spiritual enrichment! Consider whether you or a friend would find meaning in one of our upcoming courses. The following are coming this spring.

Now the Silence, Now the Songs — Online, March 13-May 8, 2018

What is our main job in life? Some say simply that it is to glorify and enjoy God forever. One way we do this is through corporate worship. But what really makes for vital and faithful worship? How do spiritual leaders best guide it?



Participants in this course will explore the theology and structure of worship as expressed in the free church tradition. We will identify “ground rules” for making corporate worship meaningful, explore a variety of worship styles, emphasize inclusion of all ages in worship, experiment with ways to use music and visual arts, and write prayers and other spoken resources.

Instructor Lani Wright helped staff the production of the denominational hymnal and supplement and many other worship resources and Bible study projects. An ordained minister in the Church of the Brethren, her day job is facilitating wellness and ecopsychology groups for people with mental illness and substance use disorders.

What Brethren Believe — Weekend intensive at McPherson College, April 12-15, 2018

What do Brethren believe? How do these beliefs translate into practice? This course will answer these questions and others by exploring Brethren beliefs related to a variety of issues, including scripture, the person of Jesus Christ, the Holy Spirit, the nature of the church, original sin, and the endtimes. We will discuss how these beliefs shape our understanding of Brethren ordinances, such as baptism, love feast, anointing, nonresistance, and nonconformity. Particular attention will be paid to the Pietist and Anabaptist origins of Brethren beliefs. The course will also examine how these beliefs and practices have changed over time and consider the diversity of beliefs found among Brethren today.



Denise Kettering-Lane is associate professor of Brethren studies at Bethany Theological Seminary. After earning an undergraduate degree in religion from Ashland University, Denise earned an MTS from Candler School of Theology at Emory University and a PhD from the University of Iowa.

Clergy Tax Seminar - Saturday, January 27, 2018

The Brethren Academy for Ministerial Leadership is once again offering a clergy tax seminar. Students, pastors, and other church leaders are invited to attend either in person at Bethany Theological Seminary or online. Pastors can earn 0.3 CEUs for the morning session.

The sessions will cover tax law for clergy, changes for 2017 (the most current tax year to file), and detailed assistance as to how to correctly file the various forms and schedules that pertain to clergy, including housing allowances, self-employment, W-2 clergy reductions, etc.

It is highly recommended for all pastors and other church leaders who wish to understand clergy taxes, including treasurers, steward commission chairs, and church board chairs.

- 1:00-2:00 p.m. EST: Lunch on your own
- 2:00-4:00 p.m. EST: Afternoon session

Registration and Cost

Registration is \$30 per person (generally nonrefundable to keep fees and overhead low). Current Bethany, TRIM/EFSM/SeBAH, and Earlham School of Religion students may attend the seminar at no cost, although registration is still required to reserve space and so sufficient materials for your attendance may be prepared. If you will be attending online, your registration will allow us to provide you with web access to the seminar; instructions and handouts will be sent a few days prior to the event.

Registrations are not complete until payment is received. For space and quality reasons, registrations may be capped at twenty-five persons locally and eighty-five persons online.
